ORDER

4. The appellant and his associates are restrained from alienating

and/or creating third party rights in the subject property.

5. The appellant is directed to cooperate with the IRP and provide

full assistance/records, as may be required.

6. The soft copy of the entire record to be provided by the

appellant to the IRP, shall also be supplied to the learned Amicus

Curiae.

7. IRP may meanwhile complete the statutory requirements as may

be required, with advance notice to the learned Amicus Curiae.
