UPON hearing the counsel the Court made the following O R D E R

1. Learned senior counsel/counsel for the parties have been heard briefly, especially in respect of the reports submitted by learned

amicus curiae, in which various suggestions/recommendations have been made with a view to protect the interest of home buyers, financial institutions, land owners and other claimant entities, as well as for completion of the ongoing project. With reference to those suggestions/recommendations, learned senior counsel/counsel for the parties are ad idem that all of them will also submit their respective suggestions to the learned amicus curiae, who may after consideration of such suggestions then submit his revised report-cum-recommendations.

- 2. Keeping the broad unanimity in this regard, the parties, including all the intervenors/applicants are permitted to submit their respective suggestions to the learned *amicus curiae* within two weeks, whereupon the learned *amicus curiae* may submit a revised report-cum-recommendations by the next date of hearing.
- 3. Meanwhile, the IRP/CoC are directed to release, as an interim honorarium, a sum of Rs.5,00,000/- per month to the learned amicus curiae from the date of his appointment. In addition, the learned amicus curiae will be entitled to the expenses that may be incurred in engaging at least one Law Clerk and the necessary Secretarial Assistants.
- 4. At the request of Mr. Shyam Divan, learned senior counsel, interlocutory application bearing I.A. No.253178/2025 is permitted to be withdrawn with liberty to file a fresh application.
- 5. Post the matter on 12.11.2025.
